### **4. First-aid Measures**

#### **Description of first-aid measures.**

##### **General advice.**

Move victim to a safe isolated area. When symptoms persist or in all cases of doubt seek medical advice.

## 5. Fire-fighting Measures

**Extinguishing media.****Suitable extinguishing media.**

Use:. Dry powder. Alcohol-resistant foam. Carbon dioxide (CO<sub>2</sub>). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

## 6. Accidental Release Measures

Stop all work that requires a naked flame, stop all vehicles, stop all machines and equipment that may cause sparks or flames. Do not breathe vapors or spray mist.
